HOLIDAY SAFETY TIPS AND WINTER DRIVING SAFETY

Be sure your holidays are happy and safe and prevent an unplanned visit from the Fire and Rescue Department (F&RD) by:

- Keeping your fresh tree well-watered
- Using only UL approved lights and not overloading circuits
- Turning off lights and electrical decorations before bedtime
- Limiting the use of extension cords
- Not using candles as decorations
- Disposing of fireplace ashes outside, away from the home, and in a strong metal container
- Never leaving candles burning when you are not in the room
- Keeping candles away from combustible materials and in a glass or ceramic container

If you do need assistance from the F&RD, you can help by making sure your address is clearly visible from the street and clearing the snow from around the fire hydrants near your home.

Winter driving requires different skills and a greater level of preparedness. Many residents are new to the area and have never driven in winter conditions. Drive defensively, stay alert, and don't talk or text on mobile phones while driving.

- Be sure tires, battery, and windshield wipers are in good condition.
- Visibility can be severely compromised by snow. Clear <u>ALL</u> windows of snow and ice before heading out on the road.
 Remove snow and ice from the top of your vehicle so it doesn't blow off and cause an accident. Keep headlights on.
- Keep your windshield washer fluid topped off. Keep a can of deicer spray in your vehicle.
- Maintain a safe distance and speed. Avoid sharp turns or quick lane changes on snow or ice. Be alert for black ice.
- Keep an emergency kit in your vehicle (blankets, food and water, small shovel, flares, extra gloves, and boots).
- Remember it is your responsibility to clear your sidewalks.
 Park your vehicle in your driveway or park on the odd numbered side so that plows can clear a wider path on the roadway and make their job easier and faster.

COMMUNITY INPUT SOUGHT FOR NORTHERN VIRGINIA TRAINING CENTER SITE

Supervisor John Cook is soliciting community input regarding the future of the former Northern Virginia Training Center site on Braddock Road. Recently he hosted a community meeting to talk with residents about the comprehensive planning process that is being launched for the site. The comprehensive planning process will allow the community to express its vision for the Training Center site and the adjacent State Police property.

Erickson Living has announced its intent to purchase the 78-acre site from the Commonwealth and is proposing to build a 1,100+ resident continuing care community there. However, this land has never gone through a Comprehensive Plan Review process.



The County has begun conducting a community needs assessment to better understand what the area currently lacks or needs to improve on regarding land use, environment, transportation, public facilities, housing, and parks and recreation. Supervisor Cook will also host a community meeting in late January to give residents the opportunity to express their opinions on community needs in person.

In order to ensure that Braddock District residents are involved throughout the comprehensive planning process, Supervisor Cook is creating a Training Center Site Task Force. Any Braddock District resident may apply by filling out an application form that can be found on his website. The Task Force will require a significant time commitment from members. The members will be selected the first of December and will begin working in early February. The Task Force will use the needs assessment and community planning meeting as a starting point from which it will develop options for a Comprehensive Plan. These options will be presented to the community at a public meeting in April 2018. The Task Force's work is anticipated to end with a community presentation of its official recommendations in late June 2018.

Supervisor Cook will share official dates for meetings via email and social media (Twitter and Facebook). He encourages citizen participation in this community planning process.

CCVCA Relations with the Larger Community

GMU West Campus Update — In June 2017, GMU issued the final report on its plans for the west campus. It is titled "George Mason University — West Fairfax Campus Vision" and is available on GMU's website at www.facilities.gmu.edu. The report discusses various options for developing three hubs, or neighborhoods, on the GMU campus for academics, innovation, and athletics. The report discusses potential impact on surrounding areas and includes a proposed timeline for development of the campus over the next 30 years.

Fairfax Federation 2017 Legislative Proposals — CCVCA belongs to the Fairfax Federation, a county-wide organization of civic associations and home owner associations. CCVCA has voted to support the legislative proposals that the Fairfax Federation has forwarded to our state senators and delegates for

consideration by the Commonwealth legislature. Many of these proposals may die in committee, but some may be enacted. To view these proposals, visit www.fairfaxfederation.org. Under "Committees" click on "Legislation." Then click on "approved legislative package" which is highlighted on the Legislation Committee page.

Other external matters (discussed in separate newsletter articles herein) include development of the NVTC site on Braddock Road, a proposed housing development for the northeast corner of Braddock and Roberts Roads, and a coat/blanket drive for Syrian refugees.

2017 BLANKET AND COAT DRIVE CONCLUDES

Since 2013, Northern Virginia citizens, businesses, local governments, religious groups, and non-profit organizations have come together to collect and donate blankets and coats to assist Syrian and Iraqi refugees who have fled their homes to other countries to escape the violence from the civil war in Syria. On November 16, the Chairman of the Fairfax County Board of Supervisors, Sharon Bulova, officially announced the 2017 launch of the Northern Virginia Blanket and Coat Drive for Syrian Refugees, stating: "We are pleased to continue this wonderful humanitarian effort and join other Northern Virginia non-profits and local governments to assist refugees abroad in need of winter coats and warm blankets."

The 2017 drive was led and organized by the Northern Virginia Relief Center (NOVARC). The drive continued until December 3, 2017. Paxton Van Lines will transport all donated items to the Port of Virginia, where they will be shipped to Lebanon via Maersk Shipping for distribution to refugees in need. In past years, shipments were made to refugees who were living in refugee camps in Turkey. As with the previous blanket and coat dives, both Paxton Van Lines and Maersk are donating their services this year. These two companies have generously shipped over 15 large moving vans of coats and blankets over the past 4 years (over 100 tons)!

Thank you to everyone who contributed to this year's drive. If you missed this year's drive, mark your calendar for November 2018, when the next drive will take place, and start gathering new or gently used blankets and winter coats to be donated then. Although collection of coats and blankets has ended, it may not be too late to make a monetary contribution specifically for the drive. HOUSING DEVELOPMENT PROPOSED AT BRADDOCK ROAD AND ROBERTS ROAD

A proposal has been filed to rezone approximately 9.56 acres on the north side of Braddock Road and east of Roberts Road from R-1 to PDH-8 to create a high-end residential development with 49 single-family detached homes. The property is currently developed with three single-family detached homes and a church, which would all be removed. The development would include amenities such as a central lawn area, community garden, pavilion, children's playground, and small corner park. Access to the property would be from a single entrance on Roberts Road. Supervisor John Cook plans to hold a community meeting on the proposal in early 2018. Watch for further information. In the meantime, please send your comments to Supervisor Cook's office. The rezoning application number is RZ/FDP 2017-BR-030.


