- The I-395 Express lanes from Edsall Road to the 14th Street Bridge are scheduled to open on November 17, 2019. For details see the November Braddock Beacon or *expresslanes.com*.
- The Board of Supervisors voted unanimously on October 29, 2019 to fund the plan to save Lake Accotink.
- The 2019–2020 Hypothermia Prevention Program has begun for the season and the no-turn-away policy is in effect for those experiencing homelessness. #### **Holiday Safety Tips**

Be sure your holidays are happy and safe and prevent an unplanned visit from the Fire and Rescue Department by:

- Keeping your fresh tree well watered
- Using only UL approved lights and not overloading circuits
- Turning off all lights and electrical decorations before bedtime
- Limiting the use of extension cords
- Not using candles as decorations, but if you must:
  - Never leave candles burning when you are not in the room
  - Keep candles away from combustible materials and in a glass or ceramic container
- Disposing of fireplace ashes outside, away from the home, and in a metal container

If you do need assistance from the Fire and Rescue Department for any reason you can help by making sure your address is clearly visible from the street and by clearing the snow around the fire hydrants near your home.

#### **Winter Driving Safety**

Winter driving is different and requires a greater level of preparedness and different skills.

- Prepare your car for winter and keep up with its maintenance:
  - Keep an emergency kit in your vehicle, including blankets, food and water, a small shovel, flares, extra gloves, and boots in the event you become stranded.
  - Check your anti-freeze level and test its effectiveness. You can buy an inexpensive tester at any auto parts store or have it checked by your favorite mechanic.
  - o Keep your windshield washer fluid topped off. Keep a can of de-icer spray in your vehicle.
  - o Be sure your tires, battery, and windshield wipers are in good condition.
- As visibility can be severely compromised by snow and ice:
  - Clear ALL your windows of snow and ice before heading out on the road.
  - Remove snow and ice from the top of your vehicle so it doesn't fall off onto other vehicles while driving and cause an accident. It's the law.
  - Keep your headlights on while driving.
- Remember that many residents are new to the area and many have never driven in winter conditions;
   therefore:
  - o Drive defensively, stay alert, and stay off mobile phones.
  - Maintain a safe distance and speed.
  - Avoid sharp turns or quick lane changes on snow or ice.
  - Be alert for black ice conditions.

Remember: if you are home during a snow storm, it is your responsibility to clear your sidewalks as soon as possible. If possible also park your vehicle in your driveway or if you park on the street, park on the **odd** numbered side of the road so that plows can clear a wider path on your street; it makes their job easier and safer.





#### Try a Low Salt Diet Around Your House This Winter

Excess salt and other deicing chemicals can harm trees, plants, and aquatic life and impact drinking water supplies. It's also not good for our pets' feet. Try a low salt diet outside this winter and minimize the amount of deicing salt that you use! You can help by following these environmentally friendly practices:

- **Shovel First!** Removing the snow first will allow the sidewalk and/or driveway to dry out and prevent thick sheets of ice from forming. If you can, shovel the snow onto your yard where it can melt into the ground.
- Sand and sawdust can be used as environmentally-friendly alternatives.
- Use salt substitutes that are less harmful, including potassium acetate (KA) and Calcium Magnesium Acetate (CMA).
- If you must use salt and deicing chemicals, follow these suggestion:
  - o Take care when applying chemical deicers; only use as much as needed.
  - Limit your use of de-icing salt near plants and environmentally-sensitive areas including streams, ponds, and wetlands.
- After the snow melts, sweep up and throw away any leftover sand and salt residues to prevent it from washing into storm drains and streams.

#### **FOG Clogs: Keep Pipes Clean this Holiday Season**

Spend the holidays with family and friends, not your plumber! Fats, oils, and grease (FOG) clog your plumbing, causing blockages and costly repairs. Keep them out of your drain.

When fats, oils, and grease are poured or washed down the drain, they build up on sewer pipe walls, restricting the flow of wastewater and over time can block the entire pipe. Blockages can send sewage out of manholes into streets and rivers or up drains into homes and businesses, creating a health hazard and harm to the environment.



Follow these easy ideas to keep the pipes in your home and under the streets clog-free:

- Can the grease. Pour grease into an empty can or container that can handle heat. Allow the hot liquid to cool or store in the freezer. Once it solidifies, throw it in the trash.
- **Wipe before washing.** To reduce the amount of grease residue left after cooking, wipe pans out with a paper towel prior to washing.
- **Seal the oil.** Mix liquid vegetable oil with an absorbent material like kitty litter or coffee grounds in a sealable container before throwing it in the trash.

#### Get Your REAL ID Before the 2020 Rush!

A **REAL ID** is a form of identification that meets increased security standards for state-issued driver's licenses and identification cards. Travelers will be required to provide either a **REAL ID** or another TSA-approved form of identification in order to fly after October 1, 2020. Your passport is also a "REAL ID" but it must be valid. If you want to fly and not take your passport within the U.S., you will need to upgrade your driver's license. REAL ID compliant credentials display a **small star** in the upper right corner to indicate they meet federal requirements. Some military bases will be requiring REAL ID credentials to enter.

What you will need to obtain a REAL ID:

- **Proof of your identity** with a birth certificate and other options
- Proof of legal presence
- Proof of Virginia residency, such as bill with your name and address
- Proof of Social Security Number, such as your SS card or W-2
- **Proof of name change**, such as a marriage certificate or court order

Be sure the DMV facility you choose issues driver's licenses. Allow plenty of time when you go. Check locations and hours and other details at https://www.dmv.virginia.gov.

#### **New Recycling Guidelines for Glass**

As of Oct. 1, 2019, residents in Fairfax County using trash and recycling collection services—regardless of which trash company used—can no longer put glass bottles and jars in curbside recycling bins. Residents must put glass in the trash or take it to the County's purple containers for glass recycling.

Fairfax County decided to remove glass from curbside recycling services after conversations with Covanta Fairfax, Inc. which runs the waste-to-energy plant and private recycling sorting centers. The County says broken glass can contaminate other recycled items such as cardboard and metals and damage machinery. Another factor is the weight of glass adding to the cost of transporting recyclables to recycling centers.

The region has a separate glass collection program through the use of 21 purple collection containers. This glass is taken to the glass processing plant in Lorton and crushed to be used for a variety of projects. Clean glass bottles and jars of all colors are accepted. Glass items not taken are lamps, light bulbs, ceramics, porcelain, mirrors, windows, and sheet glass. Other jurisdictions participating in the purple container program are Fairfax County, City of Alexandria, Arlington County, and Prince William County.

- Fairfax County Recycling and Disposal Center: 9850 Furnace Road, Lorton, VA 22079

#### Allowed items:

- ✓ cartons, such as milk and broth
- ✓ metal food and beverage cans
- ✓ mixed paper and cardboard
- ✓ plastic bottles and jugs (with lids on)

#### Not allowed:

- batteries
- clothing
- **×** diapers
- film and pillow packaging
- foam and plastic takeout containers and cups
- food bags and wrappers
- hangers
- hoses and cables
- mixed packaging
- × needles and medical waste
- plastic bags
- shredded paper
