

Anyone who can recall other recipients, please notify the Scholarship Chair; I'd like to compile a much longer list of winners!

CCVCA annually awards scholarship(s) to graduating high school senior children of CCVCA members. (If you have paid your dues prior to 15 March 2022, you qualify!). The Paul A. Maltagliati Memorial Scholarship is awarded based on academic achievement, participation in school and community activities, a short essay, and an interview with the Scholarship Committee. The exact amount awarded and number of scholarships vary based on the funds available. For 2021 we were fortunate to receive an anonymous \$1,000 Donation at the last moment, allowing us to provide three worthy young ladies with \$1,000 each to start off their college careers. (Note: most funding comes from the Scholarship Fund donations on the annual Membership form). For 2022, the Ice Cream Social Raffle has already raised \$772 toward the scholarships. #### **Winter Safety Tips**

#### **Heating Safety**

- The number one safety tip revolves around your winter heating system. Whether you have gas or oil furnaces or have a wood burning system, it is important to have it checked by a reputable maintenance company to ensure they are clean and functioning efficiently.
- ✓ It is especially important to have your chimney and flu cleaned and inspected if you burn wood. Wood byproducts over time can coat the chimney liner and lead to a roaring fire several feet above your fireplace.
  - You can tell if you a have a problem if the chimney is drawing in more air than normal, and you hear a roaring sound. This is a chimney on fire. If this happens, call 911 immediately, and if you can, close the fireplace glass front if you have one to reduce the amount of fresh air being drawn up to the fire. Then evacuate your residence.
  - Also be sure to place all ashes in a metal container and store outside away from your home. Ashes are deceiving and stay hot for a significant length of time. DON'T store the container on your deck. That is the cause of the majority of winter house fires in the county.

#### **Holiday Safety**

- Keep your fresh tree well watered.
- Use only UL approved lights and do not overload circuits.
- Turn off all lights and electrical decorations before bedtime.
- Limit the use of extension cords.
- Do NOT use candles as decorations.
- Dispose of fireplace ashes outside, away from the home, and in a metal container.
- Never leave candles burning when you are not in the room.
- Keep candles away from combustible materials and in a glass or ceramic container.



If you do need assistance from the Fire and Rescue Department for any reason you can help by making sure your address is clearly visible from the street. When there is snow on the ground you can also clear the snow from around the fire hydrants near your home.

#### **Winter Driving Safety**

Winter driving is different and requires different skills and a greater level of preparedness. Remember that many residents are new to the area and many have never driven in winter conditions, so drive defensively, stay alert, and put down the mobile phone.

- Be sure your tires, battery, and windshield wipers are in good condition.
- Check your anti-freeze level and test its effectiveness. You can buy an inexpensive tester at any auto parts store or have it checked by your favorite mechanic.
- Visibility can be severely compromised by snow, so be sure you clear ALL your windows of snow and ice before heading out on the road. Also, remove snow and ice from the top of your vehicle so it doesn't blow off onto other vehicles and cause an accident. It's the law. Keep your headlights on while driving.
- Keep your windshield washer fluid topped off. Put a can of deicer spray in your vehicle.
- Maintain a safe distance and speed. Avoid sharp turns or quick lane changes on snow or ice. Be alert for black ice conditions.
- Keep an emergency kit in your vehicle (blankets, food and water, small shovel, flares, extra gloves, and boots) for use in the event you are stranded.
- If you are home and snow is forecasted, remember it is your responsibility to clear your sidewalks as soon as possible. If possible, park your vehicle in your driveway or if you park on the street, park on the **odd** numbered side so that plows can clear a wider path on the roadway and make their job easier and faster.

#### This Holiday Season: Can the Grease to Prevent Sewer Backups

Did you know that fats, oils, and grease (FOG) can clog sewer pipes?

FOG includes materials like butter, cooking oil, lard, meat scraps, shortening, and margarine. When these materials are dumped down the drain, they form large, thick clumps of grease that clog the sewer pipes. Clogged pipes can cause sewage backups in your home, can create environmental and health problems, traffic tieups, and even flooded businesses. Cleanup can be expensive.

#### What you can do to fight FOG:

- Keep an empty metal can and pour cooking grease into the can. Allow grease to cool in the container before throwing it in the trash.
- Use a paper towel to wipe out the remaining grease from pans prior to washing.
- Place liquid oils in a sealable container before throwing in the trash.
- Keep drains clean by pouring 1/2 cup baking soda down the drain followed by 1/2 cup white vinegar. Wait 10 - 15 minutes and then rinse with hot water.

#### **Concerns by CCV Residents get Legislative Action**

Country Club View is a member of the largest civic organization in Fairfax County, the Fairfax County Federation of Citizens Associations. In chats with CCV residents, several community-wide concerns frequently pop up, such as the water-main installation, the street paving, storm water runoff into the Chesapeake Bay, noise abatement, and advance notification of construction projects. We aren't alone with these complaints.

The Federation, by using input from CCV and other county residents, annually develops a Legislative Issues Package that addresses these kinds of concerns affecting the welfare of Fairfax residents. This package is made publicly available and sent to the Board of Supervisors and the twenty-six members of the Fairfax delegation to the General Assembly (GA) for their consideration and action.

Federation committees do extensive research on the relevancy and history of these issues to produce the Legislative Issues Package. Four of this year's eight issues related to the above specific concerns of CCV residents is briefly summarized here. All issues have a detailed one-page write-up and can be accessed by clicking on the blue box "2022 Legislative Issues Link" at https://www.fairfaxfederation.org/.

- (1) Lawn-care Company Regulatory Authority The GA should enact legislation that authorizes Counties to license landscaping and lawn-care entities and to regulate the application of fertilizers, pesticides, and herbicides.
- (2) **Renewable Distributed Energy** The GA should enact or improve various laws pertaining to improving solar programs, electric utility billing rates, resiliency, energy set-asides, energy tax credits, and certain electric charging practices.
- (3) **Community Input into Zoning** The State Legislature shall amend the Virginia Code to ensure that an urban form of county government maintain public input into zoning decisions affecting single family home communities.
- (4) **Mandatory Public Notice** State Legislature shall amend the Virginia Code to extend the requirement for advance (at least 90 days) public notice and comment for all proposed and planned construction projects on State property in local jurisdictions.

These issues for which CCV and other Fairfax residents have expressed concerns are on the way to our legislators. The General Assembly meets in January with many new members in the House (but the Fairfax delegation is intact!). The Federation visits members during session to push for legislative action on the issues. So stay informed, read 'em, and please don't hesitate to chat with me about any for more info.

#### Only Rain Down the Drain!

Did you know? The Fairfax County storm drainage system, known as the Municipal Separate Storm Sewer System (MS4), carries stormwater to nearby ponds, streams, lakes, and rivers. Please do not dump anything down the storm drains. Do not rake or dump grass clippings or leaves into the storm drainage system. Never dump treated swimming pool water, pet waste, used motor oil, paint, chemicals or other substances into a storm drain. Secure garbage on collection days to avoid litter reaching the stormwater system.

#### **Fall Membership Meeting Recap**

On Monday, September 27 CCVCA held our Fall Membership Meeting. This is one of two annual meetings during which all members of CCVCA are invited to attend. While monthly Board meetings are typically hosted at Board member homes, our Fall Meeting was graciously hosted by St. Mary's Catholic Church where we spread out in a large meeting room.

The meeting was called to order at 7:30pm. We first heard from our guest speaker Traci Kendall, the George Mason University Executive Director of Community and Local Government Relations.

Ms. Kendall reported that the university is very proud of its COVID-19 response. At the time of the meeting in late September, 91% of students and staff were vaccinated and those who are not yet vaccinated are tested weekly. The university maintains a COVID-19 dashboard online that anyone can check for current rates on campus.

Of great interest was the update on the University Master Plan, which "will be a framework to guide future decision making around the University's three primary campuses in Arlington, Fairfax, and Prince William." The University is wrapping up two years of gathering feedback from various constituents and is poised to propose a "bold long-term vision" for the future of GMU. Earlier this year CCVCA established a Liaison to GMU Chair on the Board of Directors in order to closely follow the developing Master Plan, as well as to maintain positive communication with our neighboring Fairfax campus. Fran DelVecchio has filled this role and has been actively following these developments on our behalf.
